Neighborhood Greening Grants

The Parks & People Foundation received a total of 85 grant applications during two 2009 funding cycles for requests totaling \$76,853.

46 of these projects were funded for a total of \$26,749. Of the applicants, 33 groups were new to the program and had not received funding from Parks & People before.

SuperKids Camp

SuperKids Camp welcomed over 750 rising 2nd and 3rd graders from 108 public schools in Baltimore City in 2009. Participants enjoyed an amazing array of enrichment activities including climbing on board the USS Constellation for some maritime education, going to the Baltimore School for the Arts for "Finding the Art in Me", and traveling along the Historic Jonestown Heritage Walk for lessons in history. All of these terrific activities plus intensive instruction in reading and math to combat summer learning loss... what a winning combination!

KidsGrow

In 2009, KidsGrow served 151 6th and 7th graders at William Paca and Franklin Square Elementary/Middle Schools. In addition to regular lessons on the environment, the students went camping at Echo Hill Outdoor School on the Eastern Shore, planted trees with members of the American Bar Association, harvested their own salad greens and read thousands of pages while participating in the annual 100 Book Challenge.

In 2009:

- CGRN shared **2,766** seed packets, **5,146** vegetable and herb seedlings, **2,617** perennials and **8.5** cubic yards of soil and compost with community gardeners.
- **900** Baltimore City public school students played in our sports leagues.
- **2,155** trees were planted in Watersheds 246 and 263.
- Our grant programs awarded **\$113,980** to **75** community organizations for park and greening projects throughout Baltimore City.
- **750** 2nd & 3rd graders from **108** Baltimore City public schools attended SuperKids Camp, our award-winning summer academic and recreational program.
- Dozens of groups from local businesses, schools and civic groups and hundreds of individuals volunteered their time to help make Baltimore a cleaner and greener place to live, work, play and learn.

Parks, enjoyed renewed interest from park groups in 2009 awarding 29 grants totaling \$87,231. Awards were used for a wide variety of valuable park projects from maintenance and small building projects to concerts and bike tours.

In 2009, Partnerships for Parks organized 19 major volunteer events in 12 parks resulting in 3,377 volunteer hours donated to the parks system for a total value of over \$68,000. Activities included trail maintenance, trash and invasive plant removal, tree planting and more.

Schoolyard Greening Initiative

In 2009, Parks & People hosted 25 workshops attended by over 100 Baltimore City school teachers who learned how to lead students in designing, installing and maintaining natural habitats in their schoolyards.

Seven of the schools Parks & People worked with formed new "Green Teams" of students and teachers interested in improving the environmental health of their schools.

Also in 2009, Parks & People in cooperation with our partners at the Baltimore City Public School System and Maryland Port Authority, removed more than two acres of asphalt from school playgrounds. In its place, we installed 7 schoolyard habitats, vegetable gardens, and outdoor classrooms and planted more than 75 trees and 500 perennials and vegetable plants on school grounds.

Public Housing Greening Initiative

In 2009, Parks & People worked with the Baltimore City Department of Recreation and Parks' Forestry Division to plant 50 new trees at Perkins Homes in East Baltimore.

In addition, we organized five community work days in public housing communities throughout the City including Westport/Mt. Winans, Brooklyn and Dukeland/Rosemont. The work days resulted in the planting of 33 new trees and approximately 780 acres of garden space.

In the spring of 2009, Parks & People staff members took part in two "Spring Kick-Off" days where they shared educational information about the benefits of trees and gardens and helped dozens of children plant flower seeds to label and take home.



Gwynns Falls Trail Council

The Gwynns Falls Trail Council added 100 new members in 2009 and hosted several successful promotional and volunteer events including a cleanup of Middle Branch Park on National Trails Day in June. In addition, 11 new interpretive panels were installed along the Trail and the final trailhead opened linking over 2,000 acres of publicly owned land for recreation.

CGRN

CGRN (Community Greening Resource Network) completed its first full year in operation in 2009. Membership grew to 67 individual and community gardens and 19 schools, all of whom benefited from top-quality workshops and a wide array of resources.

One of CGRN's most popular benefits is Giveaway Day at which members receive seedlings, compost, soil and more at no cost. **In 2009, 2,766 seed packets, 5,146 vegetable and herb seedlings, 8.5 yards of soil and compost, 2,617 perennial plants and bulbs, and 38 flats of annuals were shared with members.**

As the name implies, the Community Greening Resource Network is truly a network of greeners and volunteers. During the 2009 growing season, 132 volunteers gave over 424 hours of service to gardens throughout the City.

Urban Resource Initiative (URI)

URI interns continued to take the lead on several important initiatives and projects in 2009 including BRANCHES (Building Resources and Nurturing Community Health and Environmental Stewardship) and Project BLUE (Baltimore Lessons in Urban Ecosystems). URI staff and interns also worked closely with the Maryland Park Service and Maryland Department of Natural Resources on the Civic Justice Corps program, a job training program for at-risk youth.
